Linux Australia Treasurer's Report for 2015

Taking on the role of treasurer has provided many challenges and opportunities for (personal) growth. My focus has been on consolidation and rather than new endeavors/altering workflows.

The 2014 council left the accounts and budget in good shape and there were no external events that caused the 2015 council to re-evaluate.

Our existing relationships have not changed. We are still using the same accounting software (Xero), auditor (Greg Middleton), accountants (Purpose Accounting) and our banking providers are Westpac (Australia) and ANZ (New Zealand).

Linux Australia worked with the following conferences since the last AGM: LCA2015, DrupalSouth Melbourne, PyCon AU 2015, Joomla Day Brisbane 2015, OSDC 2015 and WordCamp Brisbane 2015. We also had a very close relationship¹ with GovaHack 2015

Due to the strong performance of these events Linux Australia is in a solid position and during the financial year² has a profit of approximately \$143k. This is due to the exceptional success of LCA 2015 and PyCon AU 2015.

Suggested improvements

Looking back

In François' 2014 report³ the following suggestions were made for the 2015 treasurer.

- 1. canceling Linux Australia's Github subscription (not needed assuming some changes to the way we host zookeepr instances)
- 2. looking into canceling our Verified by Visa membership
- 3. investigate getting a separate Xero account for New Zealand to allow New Zealand
- 4. conferences to use Xero properly
- 5. revising our ANZ accounts so that two authorizations are required for all payments All Items have commenced though to be perfectly frank none are complete.
